INSTRUCTION MANUAL

PRODUCT INTRODUCTION

- This device is a Bluetooth MP3 player developed for car-used, which equipped with professional high-performance Bluetooth module and MP3 decoder chip. It can play and transmit the music from USB to car stereo via FM radio signal. It can transmit your mobile phone's music to car stereo via Bluetooth. It can also be used as a hands-free car kit during driving. This device transmits a wireless signal that is received by the radio, no need to modify anything in car.
- This product adopts the FM full frequency wireless transmission technology which can read mobile phones via Bluetooth and can playback audio in BT/USB modes directly on the radio. The unit supports Bluetooth hands-free call and it features an LED display screen. It also supports mobile charging with an output of 5V, 2.4A-3.1A.
- Please use the specified voltage (DC 12V/24V), otherwise it may cause the unit to malfunction or get damaged. If not used for a long period of time, please disconnect the device from the cigar lighter power supply. During use the unit will avoid local FM radio frequency. It is suggested to find a higher channel to optimize playback. Sound quality is dependent on the radio FM reception and channel.

INTRODUCCIÓN DEL PRODUCTO

- Este dispositivo es un reproductor MP3 Bluetooth desarrollado para automóviles, que está equipado con un módulo Bluetooth profesional de alto rendimiento y un chip decodificador MP3. Puede reproducir y transmitir la música desde el USB al estéreo del automóvil a través de la señal de radio FM. Puede transmitir la música de su teléfono móvil al estéreo del automóvil a través de Bluetooth. También se puede utilizar como equipo de manos libres para el automóvil durante la conducción. Este dispositivo transmite una señal inalámbrica que es recibida por la radio, sin necesidad de modificar nada en el automóvil.
- Este producto adopta la tecnología de transmisión inalámbrica de frecuencia completa FM que puede leer teléfonos móviles a través de Bluetooth y puede reproducir audio en modos BT/USB directamente en la radio. La unidad admite llamadas manos libres Bluetooth y cuenta con una pantalla LED. También admite carga móvil con una salida de 5V, 2.4A-3.1A.
- Utilice el voltaje especificado (CC 12 V / 24 V), de lo contrario, la unidad podría funcionar mal o dañarse. Si no se utiliza durante un período de tiempo prolongado, desconecte el dispositivo de la fuente de alimentación del encendedor. Durante el uso, la unidad evitará la frecuencia de radio FM local. Se sugiere buscar un canal más alto para optimizar la reproducción. La calidad del sonido depende del canal y la recepción de la radio FM.

PRÉSENTATION DU PRODUIT

- Cet appareil est un lecteur MP3 Bluetooth développé pour les voitures, équipé d'un module Bluetooth professionnel hautes performances et d'une puce de décodeur MP3. Il peut lire et transmettre la musique de la USB à l'autoradio via un signal radio FM. Il peut transmettre la musique de votre téléphone portable à l'autoradio via Bluetooth. Il peut également être utilisé comme kit voiture mains libres pendant la conduite. Cet appareil transmet un signal sans fil qui est reçu par la radio, pas besoin de modifier quoi que ce soit dans la voiture.
- Ce produit adopte la technologie de transmission sans fil pleine fréquence FM qui peut lire les téléphones portables via Bluetooth et peut lire l'audio en modes BT/USB directement sur la radio. L'unité prend en charge les appels mains libres Bluetooth et dispose d'un écran d'affichage à LED. Il prend également en charge la charge mobile avec une sortie de 5V, 2.4A-3.1A.
- Veuillez utiliser la tension spécifiée (DC 12V / 24V), sinon cela pourrait entraîner un dysfonctionnement ou endommager l'appareil. S'il n'est pas utilisé pendant une longue période, veuillez débrancher l'appareil de l'alimentation de l'allume-cigare. Pendant l'utilisation, l'appareil évitera la fréquence radio FM locale. Il est suggéré de trouver un canal plus élevé pour optimiser la lecture. La qualité du son dépend de la réception radio FM et du canal.

BASIC OPERATIONS:

- Insert the player into the car cigarette lighter.
- Find an empty FM radio station and Set the transmitter's frequency to the same car FM station.
- On your mobile device's Bluetooth settings, search for QFX FMT-13 and connect.
- Choose your favorite music app, play a song, and turn up the car radio volume.

OPERACIONES BÁSICAS:

- Inserte el reproductor en el encendedor de cigarrillos del automóvil.
- Busque una estación de radio FM vacía y configure la frecuencia del transmisor en la misma estación FM del automóvil.
- En la configuración de Bluetooth de su dispositivo móvil, busque QFX FMT-13 y conéctese.
- Elija su aplicación de música favorita, reproduzca una canción y suba el volumen de la radio del automóvil.

OPÉRATIONS DE BASE:

- Insérez le lecteur dans l'allume-cigare de la voiture.
- Trouvez une station de radio FM vide et réglez la fréquence de l'émetteur sur la même station FM de voiture.
- Dans les paramètres Bluetooth de votre appareil mobile, recherchez QFX FMT-13 et connectez-vous.
- Choisissez votre application musicale préférée, écoutez une chanson et augmentez le volume de l'autoradio.



1. USB Port: 3.1A output for quick charging.
2. USB Port: For audio playback, also supports 1A charging.
3. Previous: Select Previous track or radio station.
4. Answer: Press to answer call. Press during call to end call. Press twice to recall previous number.
5. Next: Select next track or radio station.
6. Display Screen: Displays function information.
7. Cigar Connector. Plug in to the car cigar port for power.
8. TF Card Port: Insert a TF card for mp3 music playback.

1. Puerto USB: salida 3.1A para carga rápida.
2. Puerto USB: para reproducción de audio, también admite carga de 1A.
3. Anterior: seleccione la pista o estación de radio anterior.
4. Responder: presione para contestar la llamada. Presione durante la llamada para finalizar la llamada. Presione dos veces para recuperar el número anterior.
5. Siguiente: seleccione la siguiente pista o estación de radio.
6. Pantalla de visualización: muestra información sobre la función.
7. Conector de puros. Conéctelo al puerto de puros del automóvil para obtener energía.
8. Puerto de tarjeta TF: Inserte una tarjeta TF para reproducir música mp3.

1. Port USB : sortie 3.1A pour une charge rapide.
2. Port USB : Pour la lecture audio, prend également en charge la charge 1A.
3. Précédent : sélectionnez Piste ou station de radio précédente.
4. Répondre : Appuyez pour répondre à l'appel. Appuyez pendant l'appel pour terminer l'appel. Appuyez deux fois pour rappeler le numéro précédent.
5. Suivant : Sélectionnez la piste ou la station de radio suivante.
6. Écran d'affichage : Affiche les informations sur les fonctions.
7. Connecteur de cigare. Branchez-vous au port de cigare de voiture pour l'alimentation.
8. Port de carte TF: Insérez une carte TF pour la lecture de musique mp3.
