FX-756 SAFETY

GENERAL SAFETY

- Before using the FX-756, please read these safety precautions and keep them for future reference.
- Improper connections and use may increase the risk of electric shock, fire and/or personal injury. The manufacturer will not be held liable in the event that the unit is used incorrectly or if the instructions in this manual are not followed.
- This car audio system is intended for personal use only. Do not use it for commercial purposes.
- Do not use any accessories not recommended by the manufacturer as they may damage the unit and/or cause injuries.
- Keep the packaging material out of the reach of children.
- This unit may be used by children aged 8 years or older, or by persons with diminished physical, sensory or mental capabilities or lacking experience or knowledge, provided that they are properly supervised on its proper and safe use.
- Do not use the unit in a potentially explosive atmosphere or in the presence of inflammable liquids, gases or dust.
- Do not use the unit in the presence of open flames or sparks. Remove any ignition sources while using the unit.
- Keep the unit dry. Do not immerse it in water or any other liquids. Do not expose the unit to water drips or splashes. Objects filled with liquids, such as vases, must not be placed on the unit.
- Do not use the unit in places exposed to humidity or inclement weather, or in damp locations.
- Do not cover the unit with newspaper, cloths, curtains or other similar objects.
- Do not directly expose the unit to sunlight or heat.

INSTALLATION SAFETY

- If the car audio system or the wiring are damaged, do not use until it has been returned to the manufacturer or the customer service department for repair or replacement.

- Do not modify the wiring yourself. If the wiring does not match the connections in your vehicle, have any modifications performed by a qualified automotive technician.
- Before connecting the unit, check to confirm that:
 - The unit and its components are undamaged. If any damage is noted, do not use the unit; return it for inspection and repair.
 - The voltage indicated on the unit's specification plate corresponds to your vehicle.
 - Do not disassemble the unit yourself. It must only be disassembled, repaired or inspected by a suitably qualified installer.
 - The car audio system must be used only in vehicles with a 12 V DC supply. Do not connect the unit to other systems (e.g. 6VDC or 24VDC).
- Local laws may restrict the use of this unit while driving and may sanction any misuse. Always abide by applicable local laws when using this unit.
- Do not allow yourself be distracted or disturbed by this unit while driving. Lack of concentration may cause an accident. Remember that you are in control of and responsible for the vehicle that you are driving.
- Do not use the unit in unsafe driving conditions (bad weather, dangerous roads, dense traffic, etc.).
- Keep the volume at a suitable level. Excessive volume may prevent you from hearing noises and outside sounds and may result in an accident. Prolonged exposure to high volumes (especially with headphones) can damage your hearing. Avoid setting the volume too high or using the unit for too long.

MAINTENANCE

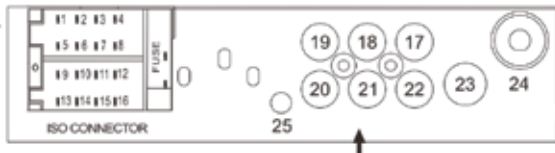
- Cleaning the unit: Wipe off any dirt on the panel with a dry silicon or soft cloth. Failure to observe this precaution may result in damage to the monitor or unit.
- Cleaning the connector: Wipe off dirt on the connector of the unit and faceplate using a cotton swab or cloth.

7. Front Left (-) Speaker WHITE/BLACK
8. Rear Left (-) Speaker GREEN/BLACK
9. Brake Line(Pink)
10. Steering Wheel Key Control Line (Brown)
11. Power Antenna/Amplifier Turn On (Blue) or NC

16. Ground Wire (Black)



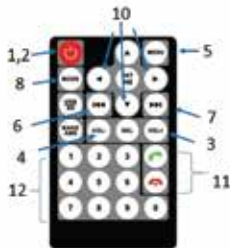

① In the off state, press short-press this button and the system will turn on.

② While on, short-pressing this will mute the volume; press-hold this button and the system will shutdown.

③ Turn this knob clockwise, the volume is increased.

④ Turn this button counterclockwise, the volume is decreased.

5 Click to enter into main interface.

6 Click to go back to the previous screen or forward.

7 Click to go the next screen or forward.

8 Press to enter the desired mode: AM/FM radio, Music, Movie, Photo or Bluetooth.

Additional modes include: USB, TF, Audio/Video, Rearview, Wallpaper and System Settings.

9 Click reset button to reset and restart the system.

10 Use the up/down/left/right buttons to navigate menus screen. Use middle button to Play/Pause music.

11 Press the green button to answer calls and red button to hang up call

12 Enter 0-9 numeric values for any functions that require it

If you experience any issues using the unit, go the System page under Settings and do a factory data reset. The factory setting password is "123456".

Region, Language as well as switches for Front or Rear Camera, Headlight and Brake Test can be set here as well.



MIRROR LINK

To set up Mirror Link, connect the USB cable between the car audio receiver and your mobile phone.

It shows "connect phone for photos or files", choose anyone to connect and start.

For Apple phones, you can connect the audio directly.

For Android phones, during Bluetooth connection, choose the Hi-Link App to install, then can connect the audio directly.

Subject to the terms and conditions herein, QFX, Inc. (herein after called "QFX") warrants to the original purchaser of the Product ("Customer") that for the applicable Warranty Period listed below, the Product will be free from defects in material or workmanship under normal, non-commercial use ("Defects").

Warranty Period encompasses, as listed below, separate "Coverage Periods" for Parts and Labor, each Coverage Period to begin from the original date of Customer purchase. If Customer returns a defective Product (or any component thereof) during the applicable Warranty Period, QFX will, at its option, during the specified Coverage Periods for Parts and Labor (as applicable either: (i) repair the Product (or, as applicable, any component thereof) or (ii) replace the Product (or, as applicable, any component thereof) with a new or refurbished Product (or, as applicable, any component thereof), in either case free of charge to Customer for Parts and/or Labor (as applicable) during the specified Coverage Period only, and excluding applicable shipping charges (noted below), for which the Customer is responsible.
