## BT-82

User Manual for the BT-82 Portable Speaker



This product is designed for teachers, tour guides, shopping guides and other personal. BT-82 has high fidelity sound, a wide frequency response, low distortion, stable performance, low noise, and low power consumption. Designed for intelligent power efficiency and low voltage power protection. It is beautiful and has a smooth design. It's small and convenient for transportation. This unit is perfect for teaching, outdoor speech, and public communication activities.

#### PRODUCT FEATURES

Microphone, Amplifier, Charger with multiple functions, and a Miniature Digital Amplifier.

The comprehensive application of electro acoustic technology and digital audio technology, shows excellent sound quality and howling suppression abilities. Using the high efficiency power amplifier (the output power is 10W) the sound projects loud and clear. The low power circuit design allows for a battery life up to 20 hours or more (Depends on usage).

The BT-82 has built-in automatic charging control circuit with saturation indication function of the large-capacity lithium ion rechargeable battery. The hanging rope and waist design is perfect for comfort and easy use. The chassis is well constructed and made of ABS engineering material for durability. The BT-82 supports .MP3 audio playback as an added feature.

**METHOD OF USE**

1. Make sure the battery is fully charged before using the equipment.  
When the battery indicator light flashes, please connect the charging cable to the power plug socket DC-5V and supply the unit with power. the Light will turn off after (8-10hr of Charging).
2. Toggle the ON/OFF switch to power ON or OFF the unit.
3. Insert a USB/TF Card to play the .MP3 audio content.

**Note**

1. Maintain the headset microphone distant from the speaker when in use to avoid feedback.
2. In case of rain immediately unplug the battery and store in a dry place.
3. Remember to turn OFF the unit when not in use to save battery consumption.
4. In order to achieve good results, please do not use the headset mic while charging the equipment, it is dangerous.
5. If the volume drops in amplitude or the power indicator light flashes, please stop using it and plug it in to charge.

**BT Connection**

1. Power on the unit. The system will display the current working mode. Use the Mode button to enable Bluetooth on the unit.
2. Turn on your mobile device's Bluetooth and search for the BT-82 and select it.
3. The BT-82 should now be paired with the mobile device for Bluetooth usage. If connection pairing fails, begin the connection process again.

Diseñado para una eficiencia energética inteligente y protección de energía de bajo voltaje. Es hermoso y tiene un diseño suave. Es pequeño y conveniente para el transporte. Esta unidad es perfecta para actividades de enseñanza, oratoria al aire libre y comunicación pública.

#### CARACTERÍSTICAS DEL PRODUCTO

Micrófono, amplificador, cargador con múltiples funciones y un amplificador digital en miniatura.

La aplicación integral de tecnología electroacústica y tecnología de audio digital muestra una excelente calidad de sonido y capacidades de supresión de aullidos. Con el amplificador de potencia de alta eficiencia (la potencia de salida es de 10 W), el sonido se proyecta alto y claro. El diseño del circuito de baja potencia permite una duración de la batería de hasta 20 horas o más (depende del uso).

El BT-82 tiene un circuito de control de carga automático incorporado con función de indicación de saturación de la batería recargable de iones de litio de gran capacidad. El diseño de cuerda y cintura para colgar es perfecto para mayor comodidad y fácil uso. El chasis está bien construido y fabricado con material de ingeniería ABS para mayor durabilidad. El BT-82 admite la reproducción de audio .MP3 como característica adicional.

**METODO DE USO**

1. Asegúrese de que la batería esté completamente cargada antes de usar el equipo. Cuando la luz indicadora de la batería parpadee, conecte el cable de carga a la toma de corriente DC-5V y alimenta la unidad con poder. la luz se apagará después de (8-10 horas de carga).
2. Mueva el interruptor ON / OFF para encender o apagar la unidad.
3. Inserte una tarjeta USB / TF para reproducir el contenido de audio .MP3.

**NOTA:**

1. Mantenga el micrófono del auricular alejado del altavoz cuando esté en uso para evitar comentarios.
2. En caso de lluvia, desenchufe inmediatamente la batería y guárdela en un lugar seco.
3. Recuerde apagar la unidad cuando no esté en uso para ahorrar batería consumo.
4. Para lograr buenos resultados, no utilice el micrófono de los auriculares mientras carga el equipo, es peligroso.
5. Si el volumen baja en amplitud o la luz indicadora de encendido parpadea, deje de usarlo y conéctelo para cargar.

**Conexión BT**

1. Encienda la unidad. El sistema mostrará el trabajo actual modo. Utilice el botón Mode para habilitar Bluetooth en la unidad.
2. Encienda el Bluetooth de su dispositivo móvil y busque el BT-82 y selecciónelo.
3. El BT-82 ahora debería estar emparejado con el dispositivo móvil para Uso de Bluetooth. Si el emparejamiento de la conexión falla, comience la ganancia del proceso de conexión.

## MÉTHODE D'UTILISATION

1. Assurez-vous que la batterie est complètement chargée avant d'utiliser l'équipement. Lorsque le voyant de la batterie clignote, veuillez connecter le câble de charge à la prise d'alimentation DC-5V et alimenter l'unité avec puissance, la lumière s'éteindra après (8 à 10 heures de charge).
2. Basculez l'interrupteur ON / OFF pour allumer ou éteindre l'appareil.
3. Insérez une carte USB / TF pour lire le contenu audio .MP3.

## Remarque

1. Maintenez le microphone du casque éloigné du haut-parleur lors de son utilisation pour éviter le larsen.
2. En cas de pluie, débranchez immédiatement la batterie et stockez-la dans un endroit sec.
3. N'oubliez pas d'éteindre l'appareil lorsqu'il n'est pas utilisé pour économiser la batterie consommation.
4. Afin d'obtenir de bons résultats, veuillez ne pas utiliser le micro du casque pendant le chargement de l'équipement, c'est dangereux.
5. Si le volume baisse en amplitude ou si le voyant d'alimentation clignote, veuillez arrêter de l'utiliser et le brancher pour le charger.

## Connexion BT

1. Mettez l'appareil sous tension. Le système affichera le fonctionnement actuel Mode. Utilisez le bouton Mode pour activer Bluetooth sur l'appareil.
2. Activez le Bluetooth de votre appareil mobile et recherchez le BT-82 et sélectionnez-le.
3. Le BT-82 doit maintenant être couplé avec l'appareil mobile pour Utilisation Bluetooth. Si le couplage de connexion échoue, commencez le gain du processus de connexion.
