# PRECAUTIONS BEFORE BATTERY USE

## Chargers and charging

- Do not overcharge the batteries. When the batteries are fully charged, please unplug the charger.
- After charging is over, please do not recharge the batteries so as to avoid overheating.
- Do not charge the batteries near flammable materials or on the surface of flammable (carpet, wooden floor, solid wood furniture, etc.) or conductive objects, and observe the batteries at any time.
- Do not charge the batteries immediately while they are still hot after use.
- The temperature of the batteries should be between 0°C and 40°C.
- Please unplug the charger when the batteries are not being charged.

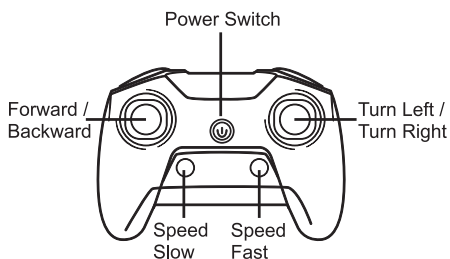
## Use and Storage

- It is strictly forbidden to pack damaged batteries with plastics.
- Do not insert or remove the batteries when the product is in use.
- Do not expose the batteries to excessive physical impact.
- It is strictly forbidden to use expanded, leaked or broken batteries or those emitting peculiar smell.
- Children are forbidden from touching the batteries.
- Do not put the batteries in the fire to avoid contact between the batteries and liquid. It is strictly forbidden to get the product wet in the rain or place it in a damp place.
- Do not put the batteries in a microwave oven or a pressure tank.
- Do not disassemble, drill, deform or cut the batteries. It is strictly forbidden to carry heavy objects on batteries or chargers or knock the batteries.
- Do not clean the charger with solvents, industrial alcohol or other flammable solvents.
- Be cautious about short circuit. Avoid direct contact with electrolytic substances in batteries.
- Electrolytic substances and electrolytic steams are harmful to the body.
- Store the product in a greenhouse. Do not expose the product to extreme temperatures.
- Avoid substantial changes in the temperature of the place where the product is stored.
- Do not place the product near the accessories of heating source.
- The batteries should be taken out when the product is not in use.

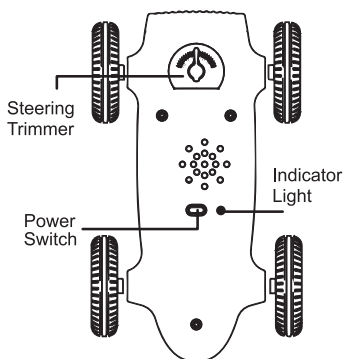

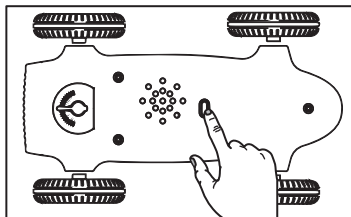
## REMOTE CONTROL AND CAR



3XAAA batteries for Remote Controller  
(Not included)



1. Press and hold the power switch to turn on the remote control, when the indicator light is on, indicate that the codes are synchronized, the car is ready for use.

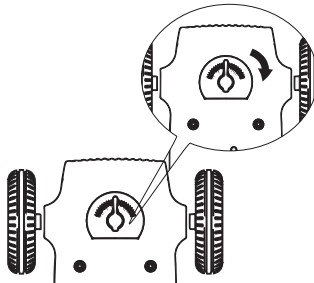
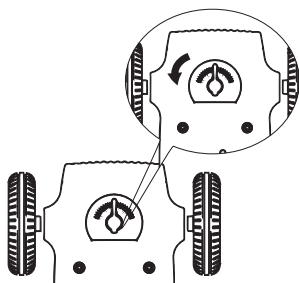


2. Press and hold the power switch for about one second to turn on the car. The indicator light will flash during this time, signaling that the car is pairing with the remote.

## TRIMMER AND CALIBRATION

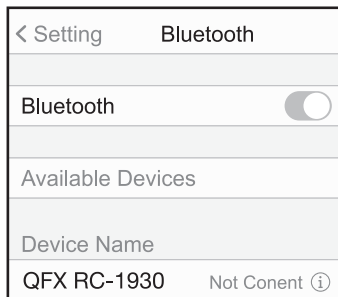
If the car drifts left, adjust the trimmer button to the right until it drives straight.

If the car drifts right, adjust the trimmer button to the left until it drives straight.

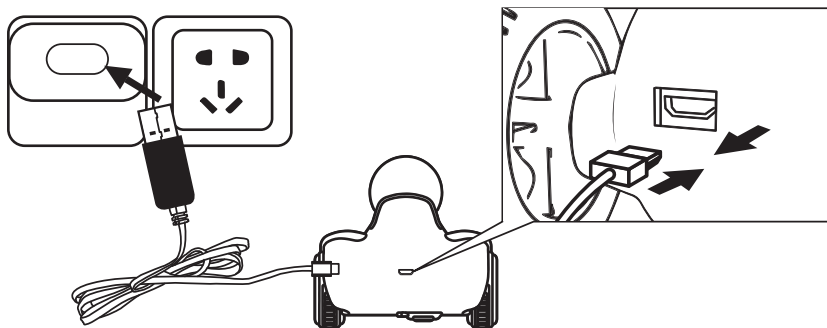


## BLUETOOTH CONNECTION

1. Press and hold the switch button to turn on the car.
2. Open the phone settings, find out the hotspot named "QFX RC-1930" on the Bluetooth list and connected, (as shown on figure).
3. After the connection is successful, it is available to play music on the APP.



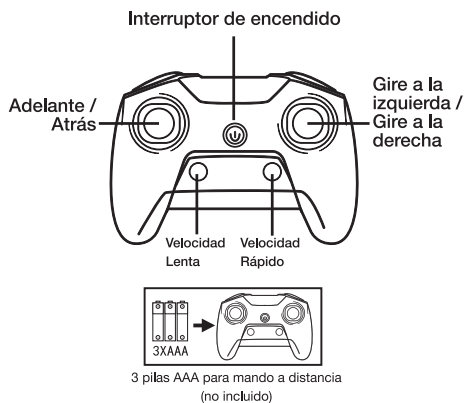
## CHARGING DIRECTIONS



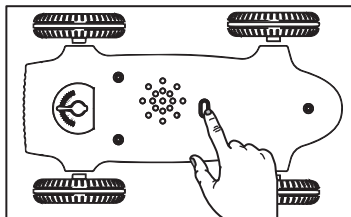
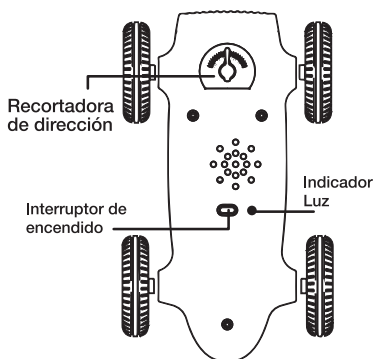
Plug the USB into the adapter and connect to the power. The USB indicator will always be on during the charging process, and be off after charging. The charging time is 90-120 minutes.

## CONTROL REMOTO Y COCHE



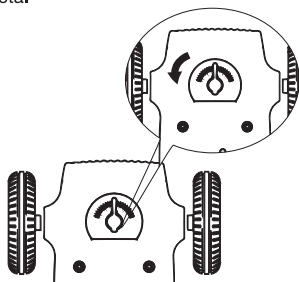

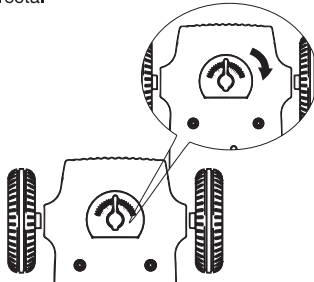

Si el vehículo se desvía hacia la izquierda, ajuste el botón del trimmer hacia la derecha hasta que avance en línea recta.

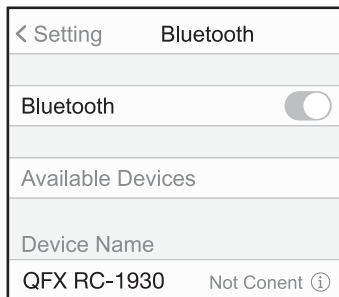
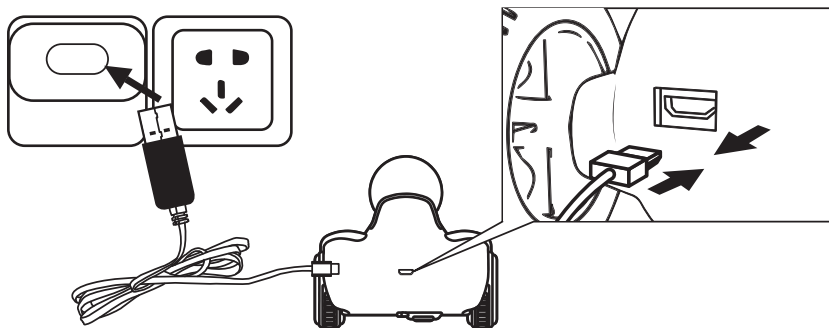


Si el vehículo se desvía hacia la derecha, ajuste el botón del trimmer hacia la izquierda hasta que conduzca en línea recta.



**RECORTADORA Y CALIBRACION**

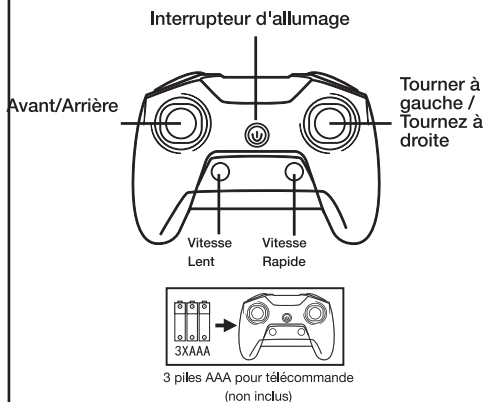
1. Mantenga presionado el botón del interruptor para encender el automóvil.

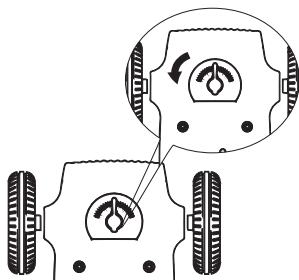

Si le véhicule tire vers la gauche, réglez le bouton du trim vers la droite jusqu'à ce qu'il se déplace tout droit.

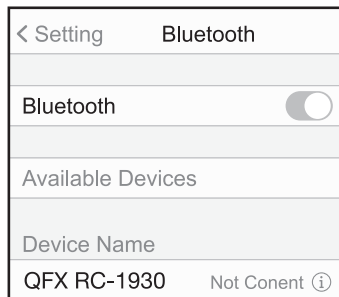

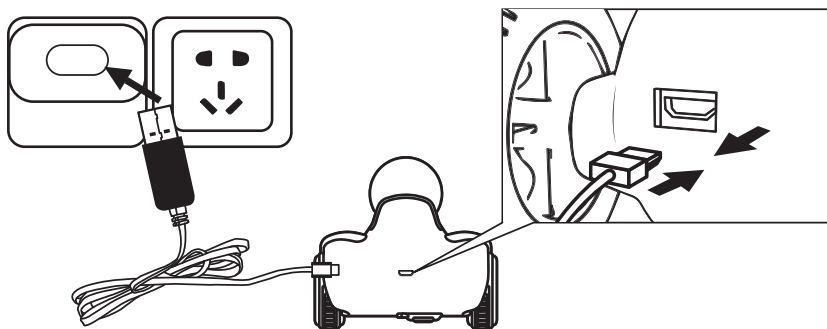


## Tondeuse et calibrage
